- Hair testing for drug exposure

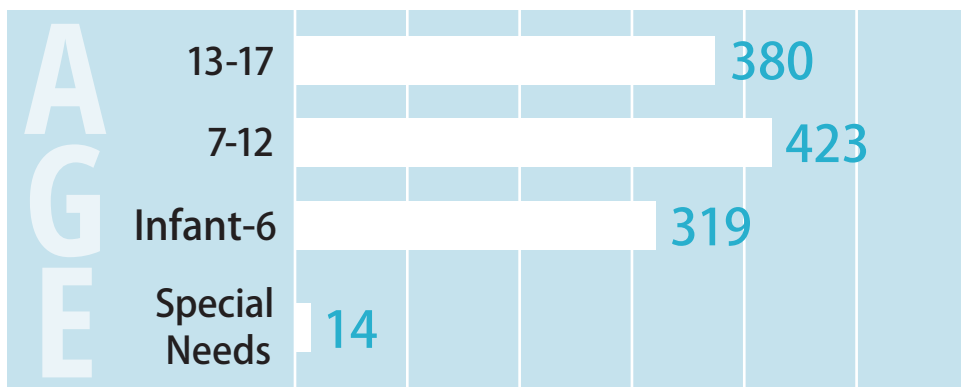
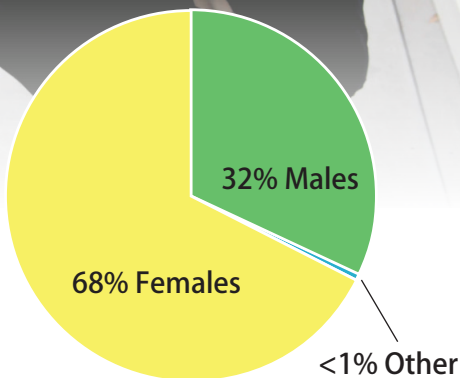
44% of children who disclosed to us in 2021 were abused in their own home.

The need continues to grow.



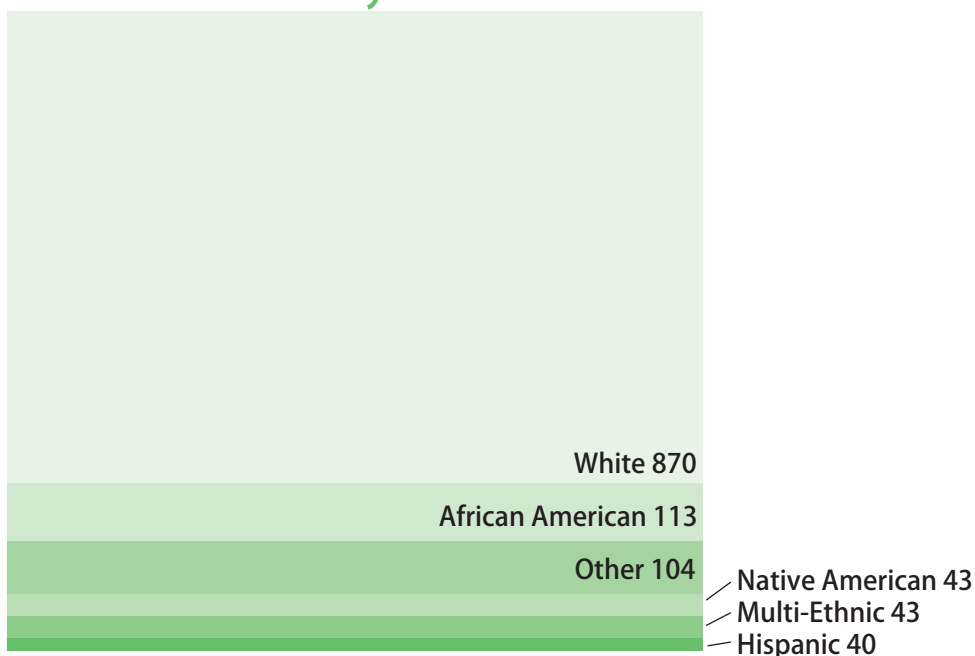

Victims Seen in 2021

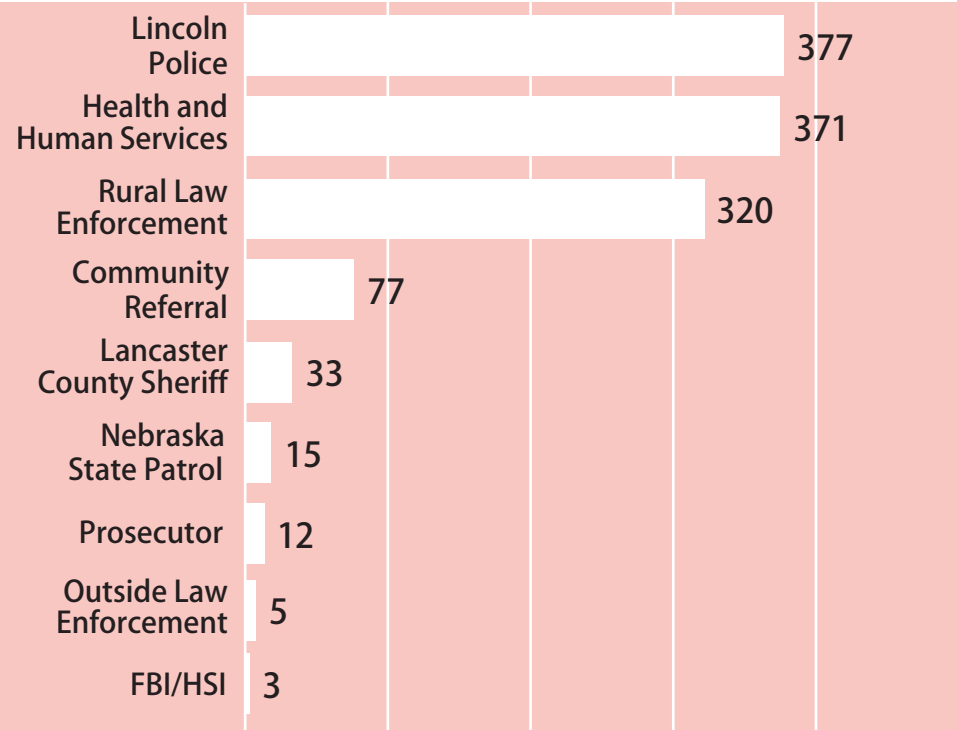

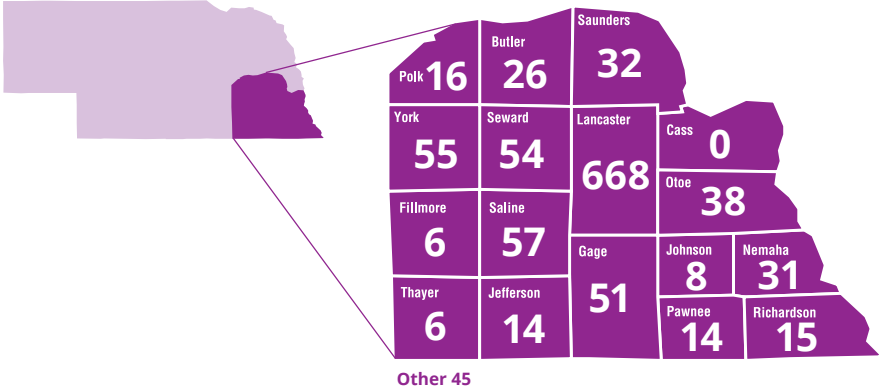
Ethnicity of Child Victims



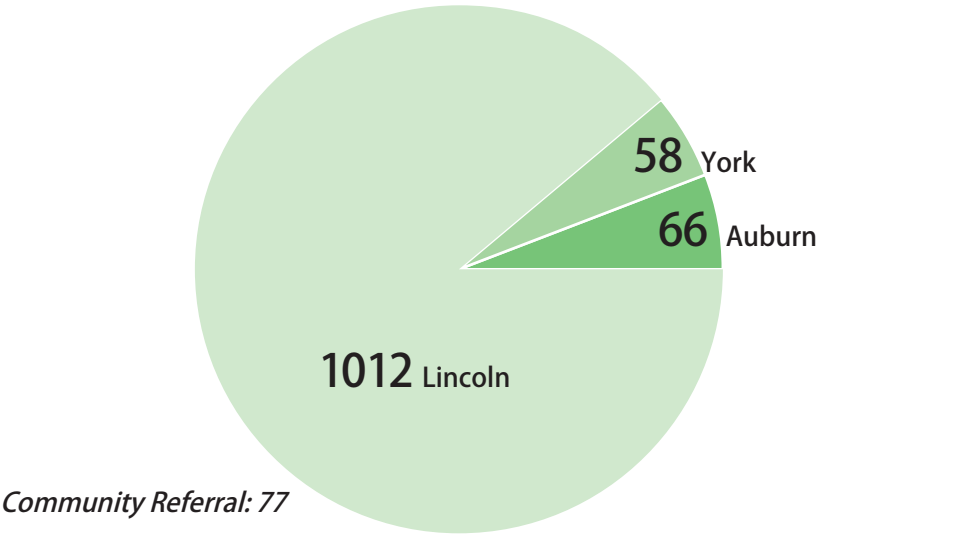
Referring Agency Comparison

Utilization of Satellite Offices *Children Seen by Location*

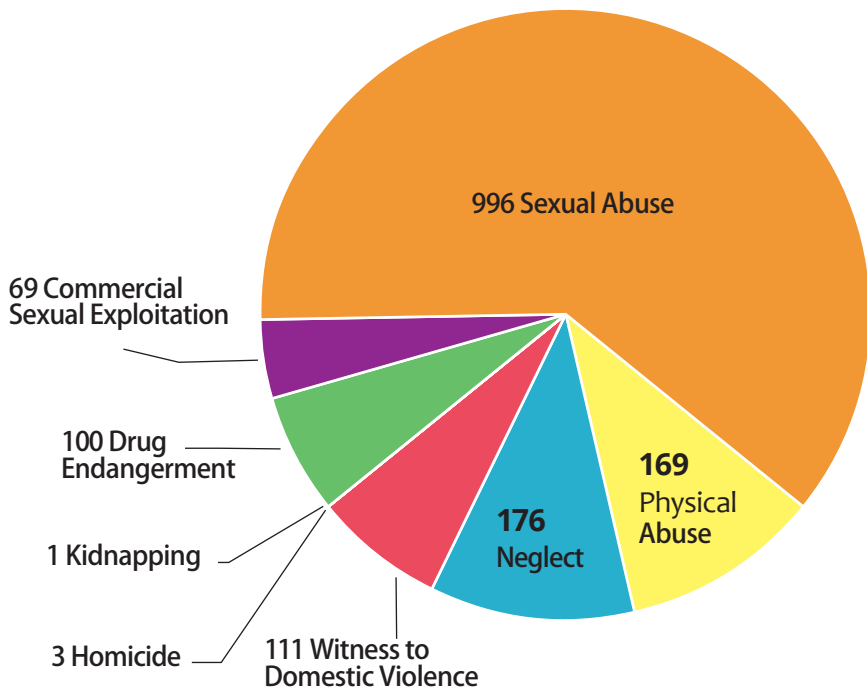




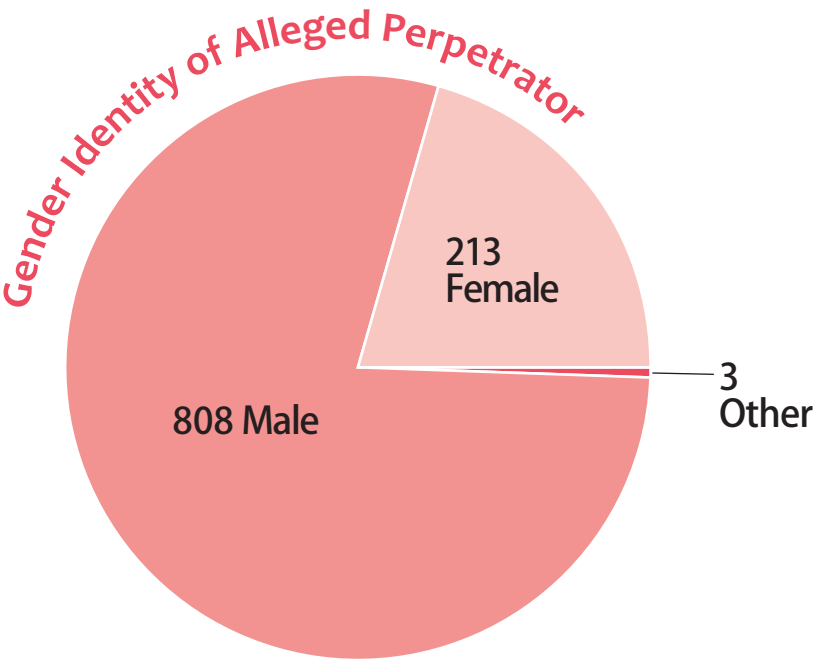
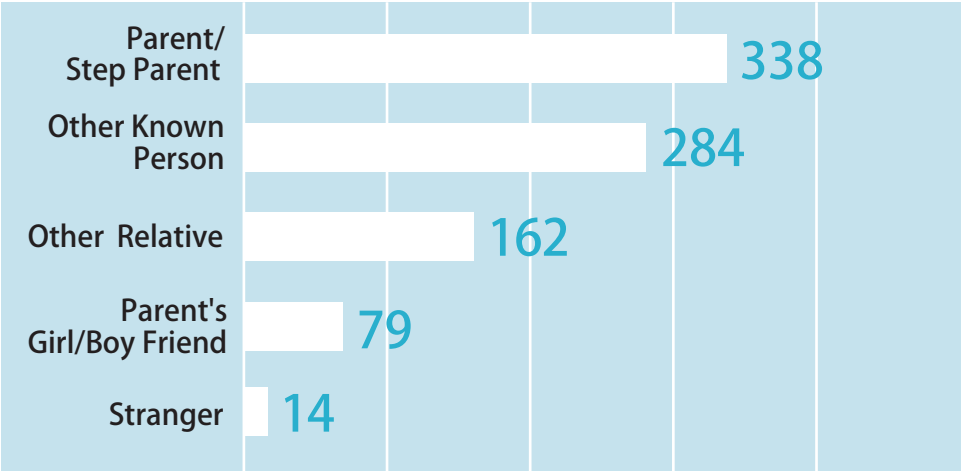

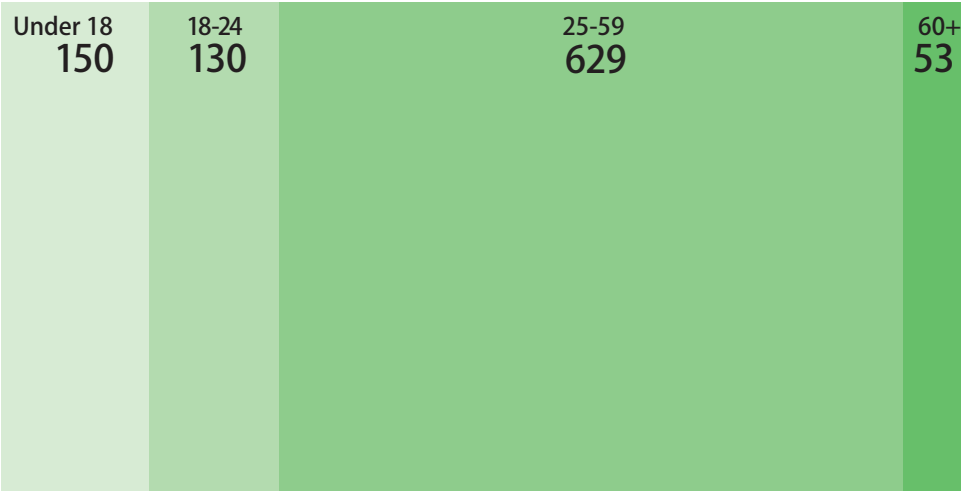
Reason for Referral



Alleged Perpetrator



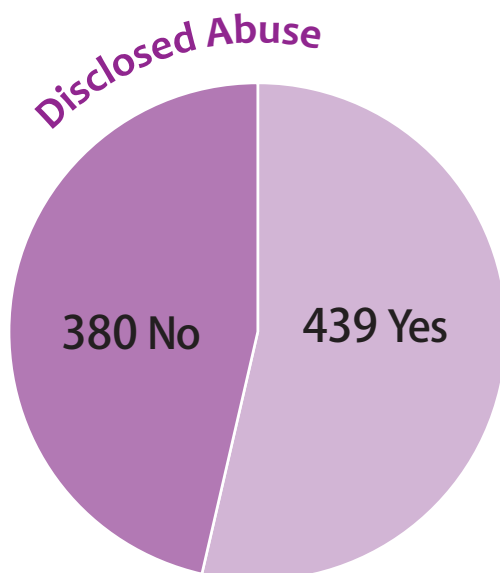
Age of Alleged Perpetrator



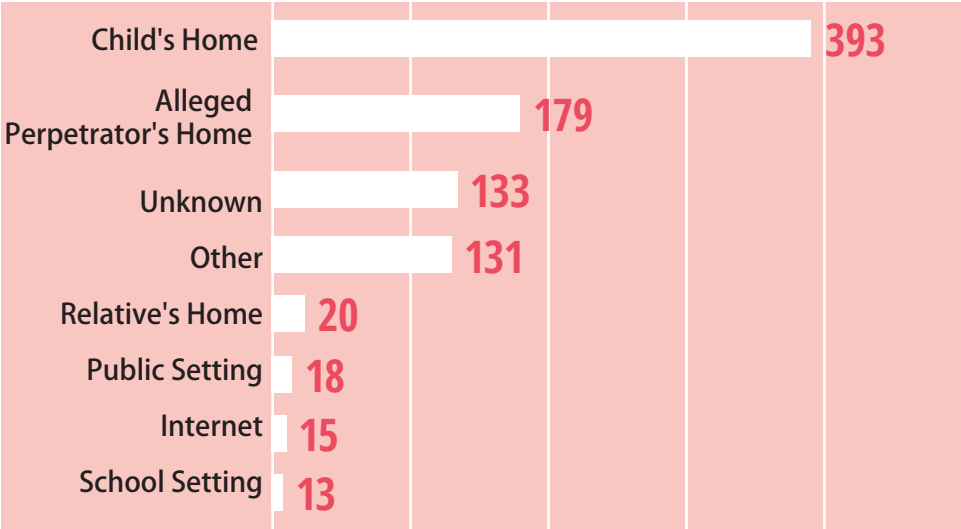

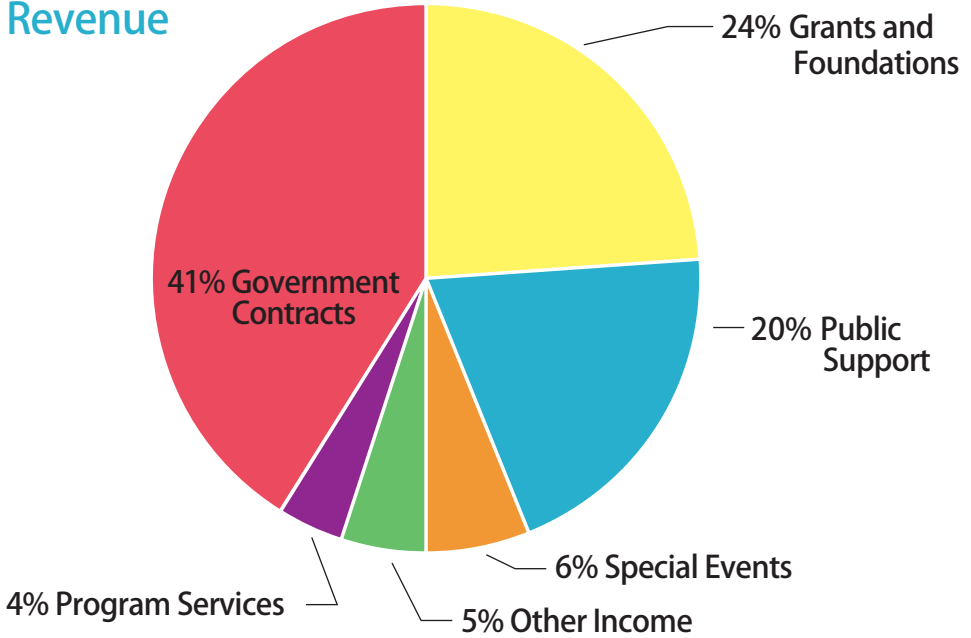

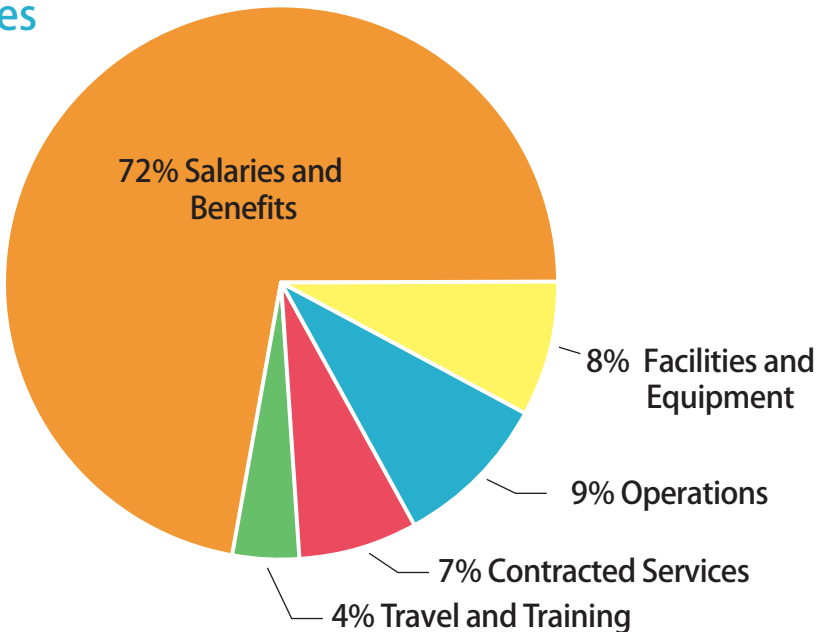
Total Hair Tests for Drug Exposure — 73% Positive Findings

Attend a training

Trainings include:

- **Darkness to Light: Stewards of Children** — learn about child sexual abuse and the steps you can take to prevent, recognize and react responsibly.
- **Child Abuse and Neglect 101** — learn about your role as a mandatory reporter and gain the knowledge and skills to recognize and report child abuse and neglect.
- **Online Safety** — With 1 in 5 children experiencing solicitation online, the dangers of technology are undeniable. Most parents feel over-whelmed when it comes to setting boundaries around technology —join us to understand where to start.
